#### OFFICE MEMORANDUM

Subject :

Payment of travelling allowance/daily allowance etc.
to State Government employees in Himachal Pradesh.

1. As a result of revision of Pay Scales with effect from 1.1.1996, the question of prescribing revised rates of travelling allowance, daily allowance etc. was receiving attention of the Government. Accordingly, in supersession of this Department Office Memorandum No. Fin (C)B(7)-2/88-III dated 24th June, 1993 and further orders issued thereunder from time to time, the Governor, Himachal Pradesh, is pleased to order that the revised rates/entitlements as indicated hereunder shall apply to the State Government employees for tours undertaken on or after 1st January, 1999.

#### 2. GRADATION :-

- (2) Government servants who claim re-imbursement of actual hotel rent shall also be entitled to daily allowance equivalent to 3/4 of daily allowance entitlements, in addition to re-imbursement of actual hotel rent.
- (3) The employees when they do not succeed in securing accommodation in Rest Houses etc. while on tour to Shimla and have to stay in Hotels and Tourist Banglows run on commercial lines shall be re-imbursed actual hotel rent upto the maximum limit as prescribed in

para 5 above for "Other Places outside Himachal Pradesh". For such re-imbursement the employees concerned shall have to produce receipt.

(4) In case of non-availability of accommodation in Himachal Bhawan at New Delhi and certificate to this effect is issued in favour of the concerned Officer/Official by the General Administration Department, tariff for stay in hotels run by the ITDC as specified vide this Department O.M. No. Fin(C)B(7)-1/97 dated 29.1.1998\* will be re-imbursed subject to the production of receipt and other conditions laid down in this behalf from time to time.

- (2) Where an official journey by train is cancelled in public interest, cancellation and reservation charges shall be re-imbursed to the Government servant directly by the Department/office concerned. In similar circumstances these charges in lespect of members of family of a Government servant shall also be re-imbursed.
- (3) Reservation charges/Surcharge levied by Railways in respect of all classes of rail accommodation will be re-imbursed to the Government servant treating these charges as part of the fare. The telegram expenses charged by the Railways in connection with the reservation of accommodation in trains, for onward and or return journeys, by Government servant travelling on duty, will also be

(2) These rates of mileage allowance prescribed for travelling by own car will apply in cases where the Government servant would themselves drive their own vehicle and do not ask for the services of a staff car or departmental vehicle driver to drive

the private car. If, however, a Government servant at his own option avails of the services of a Government driver to drive his own car, the rate of mileage allowance payable to him will be Rs. 0.50 per K.M. less for the hilly areas and 25 paisa per K.H. less for plain areas. Such facility of Staff car drivers will be allowed only to those officers who are otherwise entitled to a staff car and staff car driver for the particular journey.

(3) Only Secretaries/Special Secretaries/ Heads of the Departments with a basic pay of Rs. 18,400/- per month and above shall be entitled to use their own car/full taxi on official tour.

# 16. TAXI CHARGES :-

The State Government servants who do not take staff car to Delhi while on tour and are entitled to travel by Air or are permitted to travel by Air shall be re-imbursed taxi charges from Airport to Himachal Bhawan or place of duty/stay at Delhi on the basis of actual or Rs. 225/- whichever is less. However, those who will avail of this benefit will not be entitled to the terminal transportation charges under para 15 above.

- 17. This O.M. shall also be applicable to members of All India Services and Central Services serving in connection with the affairs of the State of Himachal Pradesh.
- 18. Similarly these orders shall also be applicable to the cases of teaching personnel of Government Colleges under the Department of Education who are in receipt of UGC scales of pay.
- 19. The other conditions of travelling allowance rules as applicable to State Government employees and instructions/decisions issued whereunder shall remain unchanged.
- 20. These orders are subject to such conditions as are prescribed by the Government from time to time under the instructions effecting economy in expenditure.
- 21. The revised entitlements of T.A./D.A. rates will be applicable w.e.f. 1.1.1999 Journey performed/tour undertaken prior

to this date shall be regulated in accordance with the old rates and the cases already decided will not be re-opened.

The Undersigned is directed to say that whenever by rail are booked through railway tickets for counters, a number of man hours are lost by standing in the queues in order to secure reservation for the entitled class. Accordingly the Government of India in supersession of the provisions of its order No. 9 below SR-34 (Swamy's Compilation of FR-SR (Part-II) as incorporated vide O.M. No. F.5-E.IV/59, dated 17.11.1959, has decided vide O.M. No. 19028/I/98-E-IV dated 3rd July, 1998 enclosed) that reimbursement of service charges levied by the traveller's Service Agents recognised by the Zonal Railways Day be allowed to be reimbursed to the Govt. servants performing transfer. However, journeys in public interest on tour or reimbursement of Service Charges paid to the recognised service agents for booking of tickets on Leave Travel Concession shall not be admissible.

The State Government of Himachal Pradesh has decided that the above decision of the Govt. of India shall also be applicable in respect of the employees of the State Government from the date of issue of this O.M.

It has been brought to the notice of this Ministry that whenever tickets for journey by rail in public interest are booked through railway counters, a number of man hours are lost by standing in the queues in order to secure reservation for the entitled class.

- 2. The matter has been considered in this Ministry and it has been decided that reimbursement of service charges levied by the traveller's Service Agents recognised by the Zonal Railways may be allowed to be reimbursed to the govt. servants performing journeys in public interest on tour or transfer.
- 3. These Orders supersede the provisions of the Government of India's Order No. 9 below SR. 34 (Swamy's Compilation of FR-SR (Part II)) as incorporated vide O.M. No. F.5/E.IV/59, dated 17.11.1959.
- 4. Reimbursement of Service Charges paid to the recognised service agents for booking of tickets on Leave Travel Concession shall not, however, be allowed.
- 5. In so far as persons serving in Indian Audit and Accounts department are concerned, these Orders issue after consultation with the C&AG.
- These orders will take effect from the date of issue.

Mode of conveyance and entitlements on Leave Travel Concession.

Consequent upon the revision of pay scales of State Government employees w.e.f. 1.1.1996, the question of revision of entitlements and mode of conveyance on Leave Travel Concession was under consideration of the Government. After careful consideration, the Governor, Himachal Pradesh, is pleased to order that the Government employees while availing Leave Travel Concession will be eligible to perform journey by the same mode of conveyance by which they are entitled to travel when on tour as per entitlements prescribed vide this Department Office Memorandum Fin-C-B(7)-14/98 dated 8th December, 1998 as modified from time to regarding payment of TA/DA, subject to the following conditions/restrictions :-

- This order will come into force w.e.f. 1.1.1999 from which date this Department Office Memorandum No. Fin(C)A(3)-21/84-II dated 30.8.1990 will cease to be operative.
- Only Grade-I Officers drawing a basic pay of Rs. 15,000/- or above per month will be entitled to perform journey by air.
- Only Officers drawing a basic pay of Rs. 18,400/- per month and above may travel by their own car subject to further conditions as detailed in this Department's O.H. No. Fin(C)A(3)-21/84 dated 23.11.1985, which are as under:
  - The car is owned by the employee concerned or any member of his family as defined for the purpose of LTC.

- (ii) The claim for re-imbursement of cost of journey is supported by vouchers of expenses on account of POL/repair/replacements enroute.
- (iii) The entitlement for re-imbursement of the cost of journey will be the actual railway fare of the entitled class by shortest route subject to a maximum of one mileage rate.
- 4. Travel in vehicles run by private operators is forebidden. There is, however, no bar to travel by vehicles operated by Government/Semi Govt./Local Body Agencies/Departments and Private Buses being plied on regular routes with the prior approval of concerned R.T.A. on regular intervals of time. This includes vehicles being operated by Central Govt./ H.P. Govt. and other State Governments.
- Journey by private taxis shall not be permissible though journeys by taxis operated by agencies (Government/Semi Govt.) mentioned against para 4 above is permissible.
- 6. For the purpose of gradation basic pay alone will be taken into account. Special pay, N.P.A. or any addition to pay known by any nomenclature shall not be taken into account.
- 7. Other conditions, definitions etc. for the purpose of Leave Travel Concession Scheme shall remain the same as circulated vide this Department O.H. No. 7-4/74-Fin(Reg) dated 6.1.1975, as modified from time to time.
- This order shall apply to the journeys undertaken on or after 1.1.1999.
