NOTIFICATION

In pursuance of the decision taken by the Government vide instructions No. EDN-A-Kha(7)06/2012-Loose-I dated, 05.08.2020 and on the recommendations of the Screening Committee constituted by the Government on 15.03.2022, the Governor, Himachal Pradesh is pleased to order to regularize the services of following PTA (GIA) provided Assistant Professors (College Cadre), in the pay scale of Rs. 15,600-39,100+6,000 (GP) per month with effect from the date of joining at their place of posting and subject to the fulfillment of the terms and conditions mentioned below:-

Terms and Conditions:-

- i) That the above regularization will be treated as fresh direct appointment and will be effective from the date of joining on regular appointment.
- ii) That these appointees will be placed at the initial of the pay scale prescribed for newly appointed Assistant Professors (College Cadre) i.e. Rs.15,600-39,100+6,000(GP), **subject to the conditions that they are qualified as per R&P Rules in vogue on the date of their initial appointment or as per the current R & P Rules in the vogue on the date of regularization.**
- iii) That the seniority of these Assistant Professors will be finalized by the Government as per the Rules, instructions issued by the Government from time to time.
- iv) That these Assistant Professor(s) will not claim the benefit of pay fixation, seniority etc. of previous service rendered on contract basis on account of their regularization.
- v) That they will remain on probation for a period of two years and during the period of probation his/her service can be terminated at any time by giving one month notice of pay in lieu thereof by the appointing authority without assigning any reason.
- vi) That the appointment shall carry with it the liability to serve in any part of Himachal Pradesh.
- vii) That they will have to give declaration for the effect that he/she has only one living spouse.

- viii) That they will have to take an oath of allegiance/faithfulness to the Constitution of India or making a solemn affirmation.
- ix) That they will have to produce all the certificates in original at the time of joining this appointment.
- x) That all the candidates shall have to pass the Department Examination as prescribed in the Himachal Pradesh Departmental Examination Rules 1997, as amended from time to time.
- xi) Selected candidate will have to submit a certificate of his/her fitness from Medical Board, DDU, Shimla. Woman candidate pregnant beyond 180 days will stand temporarily unfit till the confinement is over. The woman candidate will be re-examined for the fitness.
- xii) The services of these Assistant Professor(s) shall be subject to the condition that the reservation in service for Scheduled Castes/Scheduled Tribe/ Other Backward Classes/ Other categories shall be treated as per the category from which the candidate belong(s) and the Assistant Professor(s) in this regard shall have to submit a certificate of SC/ST/OBC/ other categories etc. at the time of submitting their acceptance report so that the points as per reservation roster can be filled up through the direct recruitment.

If, the above terms and conditions are acceptable to him/her, he/she should submit his/her joining report at his/her place of posting within a week's time from the issue of this notification to the Government through the Principal concerned, failing which this offer of appointment/regularization shall stand cancelled and no further extension will be accorded. No further correspondence shall be entertained in this behalf.
