

**APPOINTMENT TO ONE POST OF MEMBER IN HIMACHAL PRADESH  
PRIVATE EDUCATIONAL INSTITUTIONS REGULATORY COMMISSION,  
SHIMLA.**

1. Application (s) on plain paper alongwith supporting documents are invited for filling up of one vacant post of Member in Himachal Pradesh Private Educational Institutions Regulatory Commission, Shimla as per provisions of Section 4 of the Himachal Pradesh Educational Institutions (Regulatory Commission) Act, 2010. The Member should be a person of eminence in public life or in the field of higher education or who has remained Secretary or above to the Government of Himachal Pradesh or held equivalent post in Govt. of India for a period of three years or more. As per provision of the act ibid the Chairperson and the Member shall not be from the same field of specialization. The present Chairperson of HPPERC is a retired Major General and member is retired Professor of a University. Member of the Commission shall be appointed by the State Government for a period of three years or until he or she attains the age of 65 years whichever is earlier and such member may be eligible for a second term subject to the upper age limit of 65 years. After the expiry of the term of office, the Member shall be ineligible for further employment or any assignment as per provisions contained in Section 4 of the Act ibid, in any of the Private Educational Institutions within Himachal Pradesh or their associate offices or companies within or outside Himachal Pradesh for a period of three years.
2. Eligible and interested candidates can send their application/ Bio-data for the post of Member, Himachal Pradesh Private Educational Institutions Regulatory Commission by post or deliver by hand at the following address on or before 12.05.2023 (5PM).

4. The appointment of Member shall be subject to the final outcome of CA No. 11290/2013 pending before Hon'ble Supreme Court of India.


