NOTIFICATION

In pursuance of the decision taken by the Government vide instruction No. PER(AP)C-B(2)-1/2014-V.II dated 30.04.2023 and on the recommendation of the Screening Committee constituted by the Government, the Governor, Himachal Pradesh is pleased to order to regularize the services of the following Assistant Professor (College Cadre)/Acharya (Sanskrit College Cadre) in the pay scale of Rs. 57,700 (Academic level 10) per month after completion of two years service on contract basis as on 31.03.2023, with effect from the date of joining at their place of posting as mentioned below and subject to the fulfillment of the terms and conditions mentioned thereafter:-

Terms and Conditions:-

- (i) That the above regularization will be treated as fresh direct appointment and will be effective from the date of joining on regular appointment.
- (ii) That these appointees will be placed at the initial of the pay scale prescribed for newly appointed Assistant Professors (College Cadre) i.e. 57,700 (Academic level 10) per month subject to the condition that they are qualified as per R&P Rules in vogue, on the date of their initial appointment.
- (iii) That the seniority of these Assistant Professors will be finalized by the Government as per the Rules/instructions issued by the Government from time to time.
- (iv) That these Assistant Professors will not claim the benefit of pay fixation, seniority etc. of previous service rendered on contract basis on account of their regularization.
- (v) That they will remain on probation for a period of two years and during the period of probation, his/her service can be terminated at any time by giving one month notice of pay in lieu thereof by the appointing authority without assigning any reason.

- (vi) That the appointment shall carry with it the liability to serve in any part of Himachal Pradesh.
- (vii) That they will have to give declaration for the effect that he/she has only one living spouse.
- (viii) That they will have to take an oath of allegiance/faithfulness to the Constitution of India.
- (ix) That they will have to produce all the certificates in original at the time of joining.
- (x) That all the candidates shall have to pass the Department Examination as prescribed in the Himachal Pradesh Departmental Examination Rules, 1997, as amended from time to time.

If, the above terms and conditions are acceptable to him/her, he/she should submit his/her joining report at his/her place of posting within 10 days time (from the issue of this notification) to the Government through the Principal concerned, failing which this offer of appointment/regularization shall stand cancelled and no further extension will be allowed. No further correspondence shall be entertained in this behalf.


