By promotion from amongst Deputy Secretaries possessing 03 years regular service or regular combined with continuous adhoc service, if deputation/transfer is to be any, in the grade failing which by promotion from amongst the Deputy Secretaries possessing 04 years regular service or regular combined with continuous adhoc service, if any, combined as Deputy Secretary and Assistant Secretary which shall also include essential service of 02 years as Deputy Secretary, failing both by promotion from amongst the Deputy Secretaries possessing 09 years regular service or regular combined with continuous adhoc service, if any, combined as Deputy Secretary, Assistant Secretary which shall also include essential service of 01 year as Deputy Secretary.

> (1) In all cases of promotion, the Continuous adhoc service rendered in the feeder post, if any, prior to regular appointment to the post shall be taken into account towards the length of service as prescribed in the rules for promotion subject to condition that the adhoc the appointment/promotion in the feeder category had been made after following proper acceptable process.

> Provided that in all cases where a junior person becomes eligible for consideration by virtue o his /her total length of the incumbents to be considered for Promotions shall possess the minimum qualifying Service of (Including the service rendered on adhoc basis, followed by regular service/appointment) in the feeder

post in view of the provision referred to above, all persons senior to him/her in the respective category/post/cadre shall be deemed to be eligible for consideration and placed above the junior person in the field of consideration. ٦

Provided that all incumbents to be considered for promotion shall possess the minimum qualifing service of at least three years.

Provided further that where a person becomes ineligible to be considered for promotion on account of the requirements of the preceding proviso, the person(s) junior to him/her shall also be deemed to be ineligible for consideration for such promotion.

EXPLANATION:- The last proviso shall not render the iunior incumbents Ineligible for consideration for promotion if the senior Ineligible persons happened to be Ex-Service-men recruited under the provisions of rules-3 of Demobilized Armed Forces Personnel (Reservation of Vacancies in Himachal State Non-Technical services) Rules, 1972 and having been given the benefit of Seniority there under or recruited under the provisions of Rule-3 of Ex-Service-men (Reservation of vacancies in Himachal Pradesh Technical Services) Rules, 1985 and having been given the benefit of seniority there under.

(2) Similarly, in all cases of confirmation, adhoc service rendered on the feeder post, if any, prior to the regular appointment/promotion against such post shall be taken into account towards length of service, if the adhoc appointment/promtion had been made after proper selection.

Provided that inter-seseniority as a result of confirmation after taking into account adhoc service rendered as reffered to above shall remain unchanged.
