NOTIFICATION

Whereas, the meeting of Departmental Promotion Committee was held on 13.10.2022 to consider the promotions of eligible Superintendent Grade-II to the post of Superintendent Grade-I (Class-I) in the Department of Education.

Whereas, on the recommendation of Departmental Promotion Committee, 67 Superintendent Grade-II were promoted to the post of Superintendent Grade-I vide this department notification No. EDN-A-Kha(02)-13/2022 dated 13.10.2022.

And whereas, the representations of Sh. Arun Kumar Sharma and Sh. Onkar Chand Supdt. Grade-II were received in this Department wherein these incumbents have claimed their promotion as Superintendent Grade-I as their junior have already been promoted.

And whereas, after examination of both representations, their candidature were found fit and thus a review meeting of the Departmental Promotion Committee was convened on 27<sup>th</sup> January 2023, which, after perusal of records pertaining to such candidates, found that they were eligible to be promoted to the post of Supdt. Grade-I as on 13.10.2022.

No extension in the joining time will be allowed in any case & failing which the promotion order shall stand withdrawn.


