OFFICE ORDER

In exercise of powers vested under Rule 4 (c) of H.P. State Legal Services Authority Rules, 1995 read with Resolution No.4 of the minutes of the meeting of Himachal Pradesh State Legal Services Authority held on 17.4.1998, the following candidates are hereby appointed and posted as **Sweeper-cum-Peon, Class-IV (on daily wages)** respectively as per rates of wages issued by the State Government from time to time:-

The daily wage appointees are directed to report for duty in their **respective District Legal Services Authority** as shown against their name(s) within the prescribed time subject to the acceptance and fulfillment of the following specific terms and conditions:-

Terms and conditions

1. The appointment is being given purely on daily wage basis.
2. It will be the responsibility of the concerned Chairman, District Legal Services Authority to inform this Authority about joining of the concerned official.
3. The appointee is required to produce all original certificates in support of his/her qualifications and age.
4. The appointee is liable to serve in any part of the State as per the administrative requirements of the Department.

5. The daily wage appointee will be paid daily as per Government rates fixed from time to time.
6. The appointment is liable to be terminated in case the performance/conduct of the appointee is not found satisfactory.
7. He/she will be entitled leave etc. as per norms of daily wager.
8. The candidate will have to submit a certificate of his/her fitness from a Government Medical Officer concerned.
9. The candidate will have to give an undertaking in writing that he/she was never convicted by any court of Law and if so, he/she will have to furnish details regarding offence committed and punishment thereof. In case of concealing of facts his/her services are liable for termination.
10. The appointee will be entitled to TA/DA, if required to go on tour in connection with his official duties as per rates applicable.
11. Certificate to the effect that he/she belongs to SC/ST/OBC category, be furnished.
12. The appointee will have to give a declaration to the effect that he/she has only one living spouse, if married.
13. The appointee will have to take an oath of allegiance/faithfulness to the constitution of India or making solemn affirmation.
14. The appointee has to produce character certificate from a Gazetted Officer to whom the candidate may be known for the last three years.
15. The appointee should produce a domicile certificate of Himachal Pradesh issued from the competent Authority.
16. Appointment is subject to verification of character and antecedents.
17. The Employees Group Insurance Scheme as well as EPF/GPF will not be applicable to daily wage appointee(s).
18. No TA/DA shall be admissible for joining the post.
19. 4 posts of Sweeper-cum-Peon (daily wages) are filled up in order to meet out the requirement of maintenance of newly constructed buildings of ADR Centres and on account of exigencies of services required as process of interview was complete before National Lockdown imposed on account of COVID-19 pandemic. The process of interview for filling up of 4 posts of Chowkidar-cum-Peon has been postponed on account of National Lockdown/curfew imposed in the State due to COVID-19 pandemic and not likely to be resumed until situation become normal. Thus, a special condition is imposed with respect to the candidates selected and appointed against 4 posts of Sweeper-cum-Peon that they will not claim any benefit of seniority inter-se the appointees for the posts of Chowkidar-cum-Peon in the ADR Centres as both category of the posts were advertised together vide advertisement No.112-LSA/Estt./Part-XI/2020, dated 18.1.2020.
20. In case any difficulty arise for considering the eligibility of the candidates for recruitment by promotion amongst the regular Class-IV Officials of H.P. State Legal Services Authority with respect to the candidates selected and appointed for the posts of both category i.e. Sweeper-cum-Peon and Chowkidar-cum-Peon (on daily wages, Class-

IV) in reference to advertisement No.112-LSA/Estt./Part-XI/2020, dated 18.1.2020, the matter may be considered for relaxation under appropriate rule.

If the aforesaid offer of appointment on the terms and conditions stipulated above is acceptable to the appointee(s), he/she may report for duty on or before **1st July, 2020** at their respective places along with documents required and medical fitness certificate, failing which the offer of the appointment shall automatically stand cancelled and the candidate will have no right to claim it.
