**TERMS AND CONDITIONS OF AUCTION**

- I. The vehicle will be sold on "As is where is basis". The auction process will be conducted in presence of Committee.
- II. The interested bidders will have to register themselves by way of depositing Rs.5000/- (Rupees five thousand only) as Earnest Money at least one day before the scheduled date of auction. The earnest money should be in the shape of Demand Draft in favour of the Member Secretary, H.P. State Legal Services Authority, Shimla-9.
- III. 25% amount of the highest bid which is finally accepted is to be deposited by the bidder (cash or Demand Draft) with the Official of the Authority at the fall of the hammer and balance 75% of the amount within two working days by way of Demand Draft failing which the amount already deposited shall stand forfeited.
- IV. In case the highest bidder fails to deposit 25% of the bid amount at the fall of the hammer, the earnest money deposited by him shall be forfeited.
- V. Where the highest bidder wishes to deposit the total amount, he/she will be allowed to do so by way of Demand Draft.
- VI. The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid. In case of failure to deposit final bidding amount, the respective vehicle will be once again taken up for re-auction.
- VII. The delivery of the auctioned vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (PAN Card, Aadhar Card etc. in case of individual and Registration Certificate etc. in case of firms).
- VIII. The possession of the vehicle will be handed over to the highest bidder after the deposit of full bid amount.
- IX. After handing over the possession of the vehicle to the highest bidder, he/she will be responsible for all the acts and liabilities arising out of the said vehicle and the Member Secretary, H.P. State Legal Services Authority will not be liable for the same.
- X. It will be the sole responsibility of the bidder to get the Registration Certificate of the vehicle transferred in his/her name from the concerned MR & LA at his own expenses expeditiously.

- XI. The auctioned vehicle will be removed by the successful bidder within two working days after depositing the bid amount, at his/her own expense.
- XII. The vehicle will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this Department.
- XIII. This Department will not owe any responsibility for transfer of vehicle and for any other liability for using the vehicle for commercial or any other purpose after sale.
- XIV. If, the successful bidder wants to scrap the vehicle, then he should have to submit the cut part of the chassis number to this office immediately.
