Sir/Madam,

As approved by Hon'ble Mr. Justice Dipak Misra, Judge, Supreme Court of India & Executive Chairman, National Legal Services Authority, National Lok Adalats will be held once in two months in this year and the next National Lok Adalat shall be held on 9th September, 2017 on all subject matters. His Lordship has also directed that vide publicity of the National Lok Adalats, including advertisement in Newspapers, shall be given by the State Legal Services Authorities.

2. The preparatory work to hold the National Lok Adalat may start immediately to have a successful Lok Adalat.
3. The following types of cases (pre-litigation and pending) may be taken up for settlement in the aforesaid National Lok Adalat:
 - (i) Criminal Compoundable Offence
 - (ii) NI Act cases under Section 138;
 - (iii) Bank Recovery cases;
 - (iv) MACT cases;
 - (v) Matrimonial disputes;
 - (vi) Labour disputes cases;
 - (vii) Land Acquisition cases;
 - (viii) Electricity and Water Bills (excluding theft cases); Service matters relating to pay and allowances and retirement benefits;

- (ix) Revenue cases;
- (x) Other civil cases (rent, easmentary rights, injunction suits, specific performance suits)etc.;
- (xi) Other cases (please specified)

4. You are also requested to inform us the number of cases identified (category wise) for placing before the aforesaid National Lok Adalats on or before 30th August, 2017. Needless to say, there is no impediment to taking up of more cases by the SLSAs in the Lok Adalats on the scheduled date and the above information is required only for perusal by the Hon'ble Executive Chairman, NALSA.
