

NOTIFICATION

In exercise of powers conferred by rule 3 of the Himachal Pradesh Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Social Impact Assessment and Consent) Rules, 2015, the Governor, Himachal Pradesh, is pleased to carry out the Social Impact Assessment for the purpose of proposed Land Acquisition in 10 villages, namely 1. Nog 2. Bahli Billa, 3. Bahli Jhaleda, 4. Bharathu, 5. Baghdi, 6. Berri Rajadian, 7. Khater, 8. Bhatar Uperli, 9. Barmana, 10. Mandi, Tehsil Sadar, District Bilaspur Himachal Pradesh.

The Village and Khasra number wise detail of proposed land at above 10 **Villages** in Tehsil Sadar, District Bilaspur Himachal Pradesh measuring 538-13-05 bighas (40.54 hectares) attached at Annexure "A" is to be acquired for the construction of Bhanupali-Bilaspur-Berri, new B.G. Railway line.

The strategy followed in Himachal Pradesh for the construction of Bhanupali-Bilaspur-Berri New B.G. Railway line is to cover minimum land, low expenditure by passing the Railway line through tunnels and bridges and with minimum environment negative impacts. The speedy construction of above Railway line will control the pollution, improve the resources of the State to a significant extent. **The project is also likely to transform the economy of Himachal Pradesh by promoting industrialization, tourism, small and medium business enterprises and trade, in order to serve multiple purposes like explore regional development, tourism, to reduce transport congestion and vehicles pollution, connectivity of region with National railway network as well as a gateway to further connect the international borders towards Leh for strategic purposes.**



Therefore, it is made clear that during the conduct of Social Impact Assessment any attempt at coercion or threat during this period will render the exercise null and void. The Social Impact Assessment will be completed within six months from its commencement. The Social Impact Assessment Unit will conduct survey, discussions and public hearings. The Social Impact Assessment Unit will also ensure that the representatives of Gram Panchayats and Gram Sabha are given proper representation while conducting the Social Impact Assessment study.

The Social Impact Assessment Unit while considering Social Impact Assessment study, will consider other things that will take into account the impact of the project on various components such as livelihood of affected families, public and community properties, assets and infrastructure particularly roads, public transport, drainage, sanitation, sources of drinking water, sources of water for cattle, community ponds, grazing land, plantations, public utilities such as post offices, fair price shops, food storage godowns, electricity supply, health care facilities, schools and educational or training facilities, anganwadis, children parks, places of worship, land for traditional tribal institutions and burial and cremation grounds. The Social Impact Assessment Unit amongst other matters will cover all the items listed under sub-section (4) and (5) of section 4 of the Right to Fair Compensation and Transparency in land Acquisition, Rehabilitation and Resettlement Act, 2013.

The Social Impact Assessment Unit after completion of consultation, survey and public hearings, will prepare the Social Impact Assessment Report under rule 3(3) of the above rules in FORM-II and Social Impact Management Plan, listing the ameliorative measures required to be undertaken for addressing the impact of the project under sub-section(6) of section 4 of the Act ibid in FORM-III under sub-rule(4) of rule 3 of the said rules.

The Railway Vikas Nigam Ltd. (Requiring Body) which is going to construct the Bhanupali-Bilaspur-Berri, new B.G. Railway Line is a Government of India Public Sector Undertaking and the land acquisition is proposed to be done under the provisions of section 2(1)(b) of "The Right to Fair Compensation and Transparency in land Acquisition, Rehabilitation and Resettlement Act, 2013". Hence, the provisions relating to consent as required under sub-section (2) of section 2 of Act ibid are also applicable in the instant acquisition.


