- The last date for receipt of tender shall be 31.08.2015 upto 1.00PM and date for opening of the bid shall be 31.08.2015 at 3.00 PM instead of 20.08.2015.
- After last line of clause 2.1 it is added that: The NSIC certificate shall also be accepted towards exemption of submission of EMD.
- 3. The clause 5.2(f) stands amended to the extent:-
  - Third point is substituted as:-Should have executed Weigh in motion towards weight enforcement for minimum 3 projects (rail/road) documentary evidence of systems in operation with testimonials.
  - The second last point "Documentation to supplement Onsite support capability of the Manufacturer for the equipment shall stand deleted.
- 4. The clause 8-Detailed Scope of work is amended to the extent:-
  - That the approach aprons 8m on each side of the weigh in motion to be provided shall not be in the scope of bidders.
  - The cabin/control room of dimension 3x4m for operation of WIM shall be in the scope of bidder.

- Clause 8(d) shall stand omitted.
- In clause 8, Under sub-heading components of the Integrated Weigh in Motion system,
  - The load cell shall substitute load sensor
  - the 13<sup>th</sup> point "overhead lane sign" shall stand deleted.
