**“Office Order”**

Subject: **Regarding BJP charge-sheet – inquiry thereof.**

Consequent upon letters received from Principal Secretary(Fisheries) to the Government of HP issued vide no-Fish-B(14)-1/2018, dated : 27-11-2018 & 30-11-2018 on the subject cited above. The government has desired to inquire in to the matter regarding allegations/complaints leveled by BJP leaders on department of fisheries. The point of inquiry on the allegation leveled will be as under:-

“हिमाचल प्रदेश सरकार का मत्स्य पालन विभाग लोगों को मछली पालन का रोजगार देने की बजाए भ्रष्टाचार करने का प्रशिक्षण देता है । इस विभाग में लोगों को मछली पालन हेतु तालाब बनाने के लिए धन राशि दी जाती है, परन्तु यदि प्रदेश में सर्वे करवाया जाए तो 95 प्रतिशत जगह तालाब बने ही नहीं । इसके लिए आई धन राशि की बन्दरवाँट हो जाती है । मंत्री, अधिकारी, कर्मचारी और यहाँ तक कि लाभार्थी भी इसमें शामिल रहते हैं ।

Where as, it has been decided that a fact finding inquiry of the ponds/raceways and community ponds etc. constructed w.e.f. FY: 2013-14 to FY: 2016-17 shall be carried out with immediate effect. The following officer of the department is hereby appointed as “Inquiry Officer” to inspect and investigates all assests created under different schemes/ component in the areas mentioned against their name as under.
