NOTIFICATION

The Governor, Himachal Pradesh, in exercise of the powers conferred by proviso to Article 309 of the Constitution of India and in consultation with the Himachal Pradesh Public Service Commission, is pleased to make the following rules further to amend the H.P. Civil Sewa Bharti (Adhiktam Ayu Seema) Niyamawali, 1980 issued vide this Government Notification of even number, dated 23.1.1980; namely:-

Short title
and Commencement:

1. (1) These rules shall be called the "Himachal Pradesh Civil Sewa Bharti (Adhiktam Ayu Seema) Amendment Rules, 2001."
- (2) These rules shall be deemed to have come into force with effect from 1st April, 2001.

Amendment of rule 3 2.

For the existing rules 3 of the Himachal Pradesh Civil Sewa Bharti (Adhiktam Ayu Seema) Rules, 1980 hereinafter referred to as the said rules, the following shall be substituted; namely:-

"The maximum age limit for direct recruitment in the case of Class-III and IV services shall be 45 years:

Provided that this maximum age limit will not be applicable to Himachal Pradesh Administrative Service, Allied Services, Police Services and in case of Forest Guards.

Provided further that the upper age limit is relaxable for the Scheduled Castes/Scheduled Tribes/other category of persons to the extent permissible under the general and special orders issued by the Himachal Pradesh Government from time to time."

Amendment of
rule 5.

3. For the existing rule 5 of the said rules the following shall be substituted, namely:-

Notwithstanding anything contained to the contrary and inconsistent in any prevalent Class-III & IV Services Recruitment and Promotion Rules, the maximum upper age limit shall be deemed to be 45 years for the direct recruitment."
