Rajiv Gandhi Swarozgaar Start-Up Yojna (RGSY) Guidelines of Fisheries Department, Govt. of HP

- 1. Name of the Scheme: The scheme shall be known as "Rajiv Gandhi Swarozgaar Start-Up Yojana (Fisheries) -2024".
- 2. Objective of the Scheme: To promote self-employment-oriented and livelihood opportunities in the State of Himachal Pradesh in the domain of fisheries.

3. Applicability of the scheme:

As per Notification No. LEP-B002/3/2023- LEP dated 01 January, 2024 (Rajiv Gandhi Swarozgaar Start-Up Yojna-2023) issued by the Secretary (Lab & Emp.) to the Government of Himachal Pradesh.

4. Extent of subsidy:-

As per Notification No. LEP-B002/3/2023- LEP dated 01 January, 2024 (Rajiv Gandhi Swarozgaar Start-Up Yojna-2023) issued by the Secretary (Lab & Emp.) to the Government of Himachal Pradesh.

5. The following conditions are to be fulfilled for disbursing incentives under investment subsidy and interest subsidy:-

All other conditions As per Notification No. LEP-B002/3/2023- LEP dated 01 January, 2024 (Rajiv Gandhi Swarozgar Start-Up Yojna-2023) issued by the Secretary (Lab & Emp.) to the Government of Himachal Pradesh, except condition mentioned at Rule 6(vi) of the scheme which will be as under:-

For being eligible for grant/adjustment of Capital Subsidy, the Enterprise has to remain in commercial production for at least 03 years. Capital Subsidy will be adjusted/ released only after physical verification of the Enterprise by the concerned Deputy Director/ Assistant Director of Fisheries or his representative after completion of 03 years.

6. Components covered under the scheme:

- 1. Establishment of small Biofloc (7 tanks of 4m dia and 1.5 height) culture system
- 2. Small-scale Backyard Ornamental fish Rearing unit (Fresh water)
- 3. Establishment of small Recirculatory Aquaculture System (RAS) (with 1 tank of 100m3 capacity)
- 4. Construction of Fish Kiosks.
- 5. Construction of New Fish Ponds including 1st Year input cost. (0.10 Hectare) per beneficiary
- 7. **Training/ Awareness:**-Awareness camps/ workshops/ seminars and trainings shall be provided by the Department at District level to make aware the farmer/ private entrepreneurs about the scheme components covered under Rajiv Gandhi Swarozgaar Yojana.

9. SOP for subsidy under the scheme shall be follow:-

- 1. Applicant shall apply on the prescribed proforma to the Deputy Director of Fisheries/ Assistant Director of Fisheries/ Senior Fisheries Officer/ Fisheries Officer of the concerned District/ Division.
- 2. The applicant should have his/her own requisite land free from all encumbrances and suitable for establishment of scheme component. In case of leased land, the lease period should be for a minimum period of ten years from the date of submission of application and the registered lease document should be included in the application.

- 3. Beneficiary has to submit matriculation or any other similar certificate as age proof.
- 4. First priority will be given to the SC/ST/Women and Divyangjan. Application will be dealt on first come first serve basis.
- 5. All beneficiaries will submit Aadhar Card, Mobile Number (Aadhar linked), Bank account details along with application form.
- 6. The project report will be accepted only on the recommendation of the Fisheries Officer/ Senior Fisheries Officer (FO/SFO) of concerned area/ district. Application will be submitted to the Assistant Director of Fisheries/Deputy Director of Fisheries (ADF/DDF) of concerned district/ division Department of Fisheries, Himachal Pradesh.

10. Selection Process:-

- 1. Preference will be given to unemployed applicants.
- 2. Preference will be given to the applicant whose annual income category-wise (General, Scheduled Caste, Scheduled Tribe and Women) is lesser.
- 3. Preference will be given to new applicants, that is, the applicants who are not existing beneficiaries of the Department of Fisheries, H.P.

11. Role of the Labour & Employment Department/Nodal Department

After completion of all formalities, the application will be submitted online on the portal i.e www.rgsy.hp.gov.in and further processing will be done as per clause no. 7 of H.P. Govt. Notification No. LEP-B002/3/2023-LEP dated 01st January, 2024 (Rajiv Gandhi Swarozgaar Yojna-Start-Up Yojana-2023). All other terms and conditions mentioned in the above notification will be valid for fisheries activities, wherever applicable.
