In exercise of the powers conferred by the proviso to article 309 of the constitution of India and all other powers enabling in this behalf, The Governor of Himachal Pradesh is pleased to make the following rules further to amend the Recruitment and Promotion Rules of class III(Gazetted), posts of section officer under the administrative control of the Treasuries & Accounts Organisation notified vide No.20-28/68-Fin(T&A) dated the 13th May, 1974 namely and further amended vide notification No. Fin (TR)A(3)-13/83 dated 30-1-86.

5) Amendment of Rule 11 of the R/P rules for the post of Section Officer.

The Existing entry in column 3 of Rule 11 of the R/P rules for the post of Section Officer shall be substituted as under:

2(1) A candidate who passes both parts of SAS(CB) Examination from an institute recognised by the Govt. of H.P. in any session shall be as Senior to the candidate passing the said examination held in a subsequent session.

6) Amendment of Rule 12 of R/P rules for the post of Section Officer.

The Existing entry in column No.3 of Rule 12 of the R/P rules for the post of Section Officer shall be substituted as under.

7) Addition of new Rules 15 in the R/P rules for the post of Section Officer.

The following shall be added as Rule 15 of the R/P Rules for the post of Section Officer in Column 1, 2 & 3.

Column No.1 - 15

Col.No.2 Departmental Examination.

Column No.3

(1) every member of the service shall pass a departmental examination as prescribed in the departmental Examination Rules, 1976, as amended from time to time, failing which he shall not be eligible to:-

- i) Cross the efficiency bar next due.
- ii) Confirmation in the service even after completion of probationary period, and
- iii) Promotion to the next higher post. Provided that an officer who qualified the departmental Examination in whole or in part prescribed under any rules before the notification of these rules shall not be required to qualify the whole or in part of the Examination, as the case may be provided further that an officer for whom no departmental Examination was prescribed prior to the notification of these rules and who has attained the age of 45 years on the

1st March, 1986 shall not be required to qualify the departmental Examination prescribed under these rules.

Provided further that an officer for whom no departmental Examination was prescribed prior to the notification of these rules and who has not attained the age of 45 years on 1-3-76 shall not be required to qualify the departmental Examination prescribed under these rules after attaining the age of 50 years for the purpose of (1) crossing of efficiency bar next due after completion of probationary period.

Confirmation in the service after

- (2) An officer on promotion to higher post in his direct line of promotion shall not be required to pass the aforesaid examination if he has already passed the same in the lower gazetted post.
- 3) The Government may in consultation with the H.P. Public Service Commission grant an exceptional circumstances and for reasons to be reduced to writing exemption in accordance with the departmental examination Rules to any class or category of persons from the departmental Examination in whole or in part provided that such officer is not likely to be considered for any other higher promotion before the date of his superannuation.
