I am directed to invite your attention to the instructions issued by Addl. Chief Secretary (Revenue) in the matter of Order passed on 13.03.2024 in the Civil Writ Petition No. 1565 of 2020-titled as Parwati Devi Vs. State of H.P and others, vide their letter No. Rev.B.E.(5)-2/2024 dated 28.03.2024.

2. In this context, attention is also invited to the SOPs / instructions issued vide this department's letter of even number dated 18.03.2023, pursuant to the directions of the Hon'ble High Court passed in LPAST No. 7314 of 2021 in CMP(M) No. 627 of 2021 dated 22.03.2022 regarding streamlining the prevailing procedure and also to ensure timely disposal of Court cases, which have further been re-iterated on 05.04.2023. These SOPs/instructions are available on the official website of this department i.e. [www.himachal.nic.in/personnel](http://www.himachal.nic.in/personnel).

3. It has been noticed that despite of these detailed SOPs/instructions, the Department(s) are not taking care to comply with the directions of Hon'ble Court(s) for a sufficient long time, resulting which Court(s) are passing adverse orders including imposition of costs on the Government. This is not only causing unnecessary embarrassment to the State, but also putting burden on the State Exchequer.


