Subject:- Providing of reservation to the disabled persons in respect of  
Class-I to IV posts/services to be filled in by direct  
recruitment - Instructions thereto regarding.

Sir,

I am directed to refer to the subject cited above and to say that the State Government has provided 3% reservation to the Persons with Disabilities in direct recruitment to Class-I to Class-IV posts/services vide Department of Personnel's letter No. PER(AP)-C-B(12)-1/99, dated the 2<sup>nd</sup> December, 1999. The Section 38 (b) of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 provides for relaxation of upper age limit for employment to persons with disabilities. Accordingly, the above referred instructions inter-alia provide that upper age limit for appointment to a post/service as prescribed in the respective Recruitment & Promotion Rules may be allowed to be relaxed by 5 years in respect of Persons with Disabilities.

2. All the Departments/State Public Sector Undertakings/  
Autonomous Bodies etc. are requested to adhere to these instructions  
strictly in letter and spirit.


