Sir/Madam,

I am directed to refer to the subject cited above and to say that the Hon'ble High Court of Himachal Pradesh vide orders dated 01.12.2022, rendered in CWP No. 318 of 2021, titled as Hari Singh & ors. Vs. State of H.P. and others, has observed that in the decided matters where the matter has been referred to the Government, the affidavit(s) of field agencies are being filed only by way of empty formality, stating that the matter has been referred to the Government. The Hon'ble High Court has already held and further re-iterated that henceforth the affidavit(s) will be filed by the concerned Additional Chief Secretary/Principal Secretary/Secretary, as the case may be, and the Court will not entertain any application for extension of time on behalf of the field agencies, like the Deputy Commissioners, Directors etc.

Accordingly, it has been decided that henceforth, in court cases where the Government is impleaded as a Respondent and the Department(s) intend to seek extension of time in order to implement / decide or assail the Hon'ble Court orders, then necessary considered comments with justification invariably be supplied by the respective field agencies/subordinate offices invariably to the concerned Administrative Department, in a time /department(s) to the concerned Administrative Department, in a time bound manner. Necessary application accompanied with affidavit for seeking

extension of time be filed before the Hon'ble Court(s) by the A/D.
