

Sir,

It is brought to your kind notice that the State Election Commission has started preparation of electoral rolls of Panchayati Raj Institutions and Urban Local Bodies in the State for the conduct of General elections scheduled to be held in near future. In pursuance to the provisions of the Himachal Pradesh Panchayati Raj (Election) Rules, 1994, HP Municipal Election Rules, 2015 and HP Municipal Corporation Election Rules, 2012 these electoral rolls are to be prepared through the respective District Election Officers (Panchayat)-cum-Deputy Commissioners, Electoral Registration Officer-cum-Sub-Divisional Officers(C), District Panchayat Officers, Block Development Officers, Tehsildars and Naib Tehsildars.

2. After the preparation of electoral rolls, process for the conduct of general elections shall be started. Since this is a gigantic exercise as about 32000 Office Bearers shall be elected in the entire State, therefore the Commission will require co-operation and assistance from all departments. The Government officials will act in various capacities, therefore vacancies, if any, may be filled on priority.


