


### **NOTIFICATION**

**No. 154/HP/2019-P.Admn.** - In exercise of the powers conferred by sub-section (1) of section 13A of the Representation of the People Act, 1950 (43 of 1950), the Election Commission of India in consultation with the Government of Himachal Pradesh hereby nominates Sh. Devesh Kumar, IAS (HP:1998) as the Chief Electoral Officer for the State of Himachal Pradesh with effect from the date he takes over charge and until further orders in place Sh. Pushpendra Rajput.

2. Sh. Devesh Kumar shall cease to hold and hand over forthwith the charge of all or any charges of work under the Government of Himachal Pradesh, which he may be holding before such assumption of office.

3. Sh. Devesh Kumar while functioning as the Chief Electoral Officer, Himachal Pradesh shall not hold any additional charge whatsoever under the Government of Himachal Pradesh except that he should be designated Secretary to the Government in charge of Election Department in the State Secretariat.
