

OFFICE MEMORANDRUM

Officers of the Central Government or State Governments for appointment to the post of Director General in the Commission on deputation on foreign service terms basis. The details of the post, along with eligibility criteria prescribed for the post are given in Annexure-I.

- 2. The person to be appointed as Director General should be a person of integrity and outstanding ability and who have experience in investigation, and knowledge of accountancy, management, business, public administration, international trade, law or economics.
- 3. The period of deputation including the period of deputation in the same or some other organisation/department of the Central/State Government shall not ordinarily exceed three years and would be governed by the terms and conditions prescribed by the Department of Personnel and Training, Government of India, vide O.M. No.6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time as well as by the GoI Notification No. GSR 338 (E) dated 15.05.2009 regarding conditions of service of DG, CCI and other Officers in that office. The maximum age limit for appointment to the post on deputation basis shall be 'not exceeding fifty eight years' on the closing date of receipt of application in the Competition Commission of India (CCI).






