Sir,

In partial modification of this department's instructions issued vide letter No.8-143/71-DP(Apptt.) dated 19.11.1973 and in supersession of this Department's instructions issued vide letter of even number dated 3.4.2019 on the subject cited above, I am directed to say that the matter regarding constitution of DPC in respect of various categories of posts belonging to Class-I & Class-II Selection posts was under re-examination for some time past. Now, it has been decided to amend the constitution prescribed for Departmental Promotion Committee to consider promotion from Class-II to Class-I and Class-III to Class-II and Class-I posts and henceforth, the Constitution of the Committee will be as under:-
