The All India Service (PAR) Rules-Annual Medical Check-up.


Sir/Madam,

I am directed to refer to this Department's notification of even number dated 10/03/2008, on the subject cited above, whereby modalities for annual health check-up were notified and all Chief Medical Officers in the districts and Medical Superintendents of Indira Gandhi Medical College, Shimla and Dr. Rajendra Prasad Government Medical College, Tanda were designated as the authorized medical authorities to issue medical certificate in favour of the All India Services officers.

It is reiterated that under the All India Services (PAR) Rules, 2007, as amended from time to time, annual health check-up is mandatory for all IAS and IFS officers above the age of 40 years and for all IPS officers without any age binding. Now, it has been decided to authorize all Government as well as empanelled private health institutions located within/outside the State for annual health check-up. The expenditure so incurred will be charged to the SOE/ head "Medical Re-imbursement" subject to restriction to the CGHS rates.
