NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and all other powers enabling him in this behalf, the Governor of Himachal Pradesh, in supersession of this Department's O.M. No.7-14/71-DP-(Apptt-II), dated 02.11.1987 and in partial modification OM of even number dated 28.08.1971, is pleased to order that the following Central Civil Services Rules shall remain applicable to the Himachal Pradesh Government employees as the same exist on the date of issuance of this notification, namely :-

1. Central Civil Services (Temporary Service) Rules, 1965
2. Central Civil Services (Classification, Control and Appeal) Rules, 1965,
3. Central Civil Services (Conduct) Rules, 1964,

2. It has also been decided by the Government that the Instructions/ Orders /Rules/ Regulations governing the following matters as issued by the Government of India from time to time shall also remain applicable to the Himachal Pradesh Government employees as the same exist on the date of issuance of this Notification subject to any further amendment made by the State Government, namely :-

1. Verification of character and antecedents ;
2. Seniority ;
3. Confirmation ;
4. Promotion ;
5. APAR [Annual Performance Appraisal Report] ;
6. Status [Gazetted or Non-Gazetted] of posts ;
7. Re-employment ; and
8. Casual Leave

4. The Governor, Himachal Pradesh is further pleased to order that henceforth any subsequent amendment(s) made in the above rules Instructions/ orders / regulations by the Government of India shall be applicable to State Services only when adopted and circulated by the State Government.



5. The cases already decided before the date of issuance of this Notification in the light of earlier instructions including instructions already adopted/ amended from time to time shall not be re-opened.

6. These instructions may be disseminated to all the concerned.
