- 3. Central Civil Services (Conduct) Rules, 1964,
- 2. It has also been decided by the Government that the Instructions/ Orders /Rules/ Regulations governing the following matters as issued by the Government of India from time to time shall also remain applicable to the Himachal Pradesh Government employees as the same exist on the date of issuance of this Notification subject to any further amendment made by the State Government, namely:-
  - 1. Verification of character and antecedents;
  - 2. Seniority;
  - 3. Confirmation;
  - 4. Promotion:
  - 5. APAR [Annual Performance Appraisal Report];
  - 6. Status [Gazetted or Non-Gazetted] of posts :
  - 7. Re-employment; and
  - 8. Casual Leave

4. The Governor, Himachal Pradesh is further pleased to order that henceforth any subsequent amendment(s) made in the above rules Instructions/ orders / regulations by the Government of India shall be applicable to State Services only when adopted and circulated by the State Government.
