

ORDER

The President is pleased to appoint **Shri Justice V.K. Sharma**, Former Judge, High Court of Himachal Pradesh as **Chairman** in the **Himachal Pradesh Administrative Tribunal** in the scale of pay of Rs. 80,000/- (fixed) from the date on which the Himachal Pradesh Administrative Tribunal is established under sub-section 2 of Section 4 of the Administrative Tribunals Act, 1985.

2. The appointment of Shri Justice V.K. Sharma as Chairman, Himachal Pradesh Administrative Tribunal will be for a period of 5 years from the date of assumption of charge of the post, or till the age of 65 years, whichever is earlier.

3. The conditions of service of Shri Justice V.K. Sharma as Chairman in the Himachal Pradesh Administrative Tribunal shall be governed by the provisions of the Administrative Tribunals Act, 1985, as amended by the Administrative Tribunals (Amendment) Act, 2006.


