ORDER

WHEREAS, in order to contain the spread of the COVID-19 pandemic to a certain extent, curfew/ lock down has been imposed as a precautionary measure in various parts of the country.

WHEREAS, it has been reported that some students/ individuals belonging to the State of Himachal Pradesh staying in PG facilities/ rented accommodation in Chandigarh have been stranded and it is not possible for them to travel to their native places in Himachal Pradesh because of restrictions imposed due to Curfew/lock down.

WHEREAS, in order to facilitate boarding and lodging of these students/ individuals, the Government of Himachal Pradesh, has decided to operate Himachal Bhawan, Chandigarh only to provide food and shelter to such stranded students/individuals vide order No. SPS/Secy/GAD/Misc/2020 dated 28th March, 2020.

AND WHEREAS, it has been felt necessary to depute some responsible officer at Himachal Bhawan, Chandigarh to act as a Nodal Officer to liaise with the local Administration, coordinate and supervise the arrangements and facilitate students/individuals stranded at Chandigarh:

NOW THEREFORE, the Governor, Himachal Pradesh, is pleased to deploy **Shri Rajiv Kumar, HPAS (2003) (Mobile numbers: 94180-08000, 70183-38203)**, General Manager, District Industries Centre, Solan, District Solan, Himachal Pradesh, as Officer-on-Special Duty at Himachal Bhawan, Chandigarh, for the purpose, with immediate effect till further orders, in the public interest.
