

Sir,

I am directed to invite your attention to this department's letter of even number dated 22.06.2017 vide which the detailed instructions regarding providing of reservation for the persons with benchmark disabilities have been issued. Attention is also invited to this department's letter No.PER(AP)-C-B(12)-2/2013-II, dated 21.11.2015 & 06.04.2017 regarding launching of special recruitment drive for clearance of shortfall and backlog of Scheduled Castes, Scheduled Tribe and Persons with Disabilities in direct recruitment against the existing/filled-in posts in each cadre.



Attention is also invited to this department's letter No.Per(AP.II)B(2)-5/2017, dated 18.08.2017 regarding granting of exemption in educational qualification to visually impaired persons who have crossed the age of 35 years for recruitment to Class-IV posts/services and Junior Office Assistant (IT) for acquiring required diploma. Accordingly, relevant provisions have been inserted in the Common R&P Rules notified by the Department of Personnel and similarly provisions in other Class-IV posts/services are to be inserted by the respective departments.
