**ORDER**

**WHEREAS**, as per intimation given by the Deputy Superintendent of Police, PS, SV&ACB, Hamirpur, District Hamirpur, Himachal Pradesh, **Shri Hari Singh Rana, HPAS (2011)**, presently posted as Registrar, H.P. Technical University, Hamirpur who is also holding additional charge of the post of Joint Director, Dr. Radhakrishanan Government Medical College, Hamirpur, District Hamirpur, Himachal Pradesh, has been arrested in case FIR No. 02/2019 dated 28.01.2019 U/S 7 and 7A of Prevention of Corruption Act (As amended in 2018), registered in Police Station SV & ACB, Hamirpur, District Hamirpur on 31<sup>st</sup> January, 2019 at 2.30 A.M. and he was produced in the Ld. Court of Special Judge District Hamirpur on 31<sup>st</sup> January, 2019 and the Ld. Court has remanded the accused Shri Hari Singh Rana to Police Custody upto 1<sup>st</sup> February, 2019.

**AND WHEREAS** the said **Shri Hari Singh Rana, HPAS (2011)**, is in Police custody since 31<sup>st</sup> January, 2019 for this alleged offence;

**NOW, THEREFORE**, the Governor, Himachal Pradesh, in exercise of the powers conferred by sub-rule (1) (b) of Rule 10 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965, hereby places the said **Shri Hari Singh Rana, HPAS (2011)**, under suspension with immediate effect.

It is further ordered that during the period that this order shall remain in force the headquarters of **Shri Hari Singh Rana, HPAS (2011)**, should be at O/o Deputy Commissioner, Kangra at Dharasmahala, District Kangra, Himachal Pradesh.


