However, the requisite panel of IAS officers for appointment to the above post is yet to be received. M/o Finance, Deptt. of Expenditure has given the approval for continuation of above post upto 31.12.2025 vide their I.D. Note no. 1575717/E.Coord.I dated 08.02.2021.

2. As you may be aware conducting decennial census is a task of national importance and preparations for the same have already commenced in all the States/UTs. Houselisting operation and Population Enumeration along with updation of NPR are going to be held in near future. The task was temporarily deferred due to spread of COVID-19 pandemic but is gaining momentum as the situation improves.

3. Dr. S. K. Kapt, IFoS (HP:1995) was holding the charge of the post from 22.11.2019 on central deputation under Central Staffing Scheme for a total period of 3 years. But, he has been pre-maturely repatriated to his parent cadre w.e.f. 31.01.2022 on personal grounds and the post is vacant since 01.02.2022. The posting of IAS officer as DCO/DCR in the State is necessary for effective supervision, coordination and maintaining good liaison with District Collectors, Heads of Department and Senior Officers of the State Governments. 2. As you may be aware conducting decennial census is a task of national importance and preparations for the same have already commenced in all the States/UTs. Houselisting operation and Population Enumeration along with updation of NPR are going to be held in near future. The task was temporarily deferred due to spread of COVID-19 pandemic but is gaining momentum as the situation improves.

3. Dr. S. K. Kapta, IFoS (HP:1995) is holding the charge of the post from 22.11.2019 on central deputation under Central Staffing Scheme for a tenure up to 31.03.2023 i.e. for a total period of 3 years. But, he has requested for pre-mature repatriation to his parent department in order to avail the benefits of promotion to HAG (Level-15) scale and his request has been forwarded to DOP&T for their consideration. It is, therefore, necessary to identify a suitable IAS officer to act as DCO/DCR in the State for effective supervision, coordination and maintaining good liaison with District Collectors, Heads of Department and Senior Officers of the State Governments.
