ORDER

WHEREAS, vide this department's Order of even number dated 1st May, 2020, Joint State Nodal Officer and Nodal Officers have been appointed Officers to collect, collate and compile the data pertaining to the requests received for interstate movement of students/ tourists/ business travellers/professionals/industrial workers/ pilgrims etc. belonging to Himachal Pradesh and other States/ UT's and formulate a comprehensive plan, devise protocol and facilitate movement by using public transport facilities/ private vehicles in consultation with the officers of the other States/ UT's, District Administration, officials of the Departments of Labour & Employment, Industries, Home, Transport, Himachal Pradesh Road Transport Corporation etc. under the overall supervision and guidance of the State Nodal Officers/ Joint Nodal Officer within the ambit of the guidelines of Government of India, M/o Home Affairs, New Delhi, as issued from time to time in this regard.

WHEREAS, the Department of Revenue-DM Cell, Government of Himachal Pradesh vide letter number REV(DMC)(C)20-2/2020-COVID-19 dated 4th May, 2020 has informed that in view of the increased workload, there is a need to amend/ revise the Order ibid and also appoint more Nodal Officers so that the interstate movement is planned, co-ordinated, facilitated and expedited in an effective manner.

NOW THEREFORE, in exercise of the powers vested in me under Clause 3 of the H.P. Epidemic Disease (COVID-19) Amendment Regulations, 2020 and in partial modification of this department's Order of even number dated 1st May, 2020, the States/ UT's assigned to the Nodal Officers are hereby amended and the following officers are designated as Nodal Officers as under:-
