

Legal Provisions in Management of Electoral Roll



PROVISIONS UNDER CONSTITUTION OF INDIA

Article 324(1) vests the superintendence, direction and control of the preparation of the electoral rolls for all elections to Parliament and to the Legislature of every State on the Election Commission.

Article 325 provides that there shall be one general electoral roll for every territorial constituency and no person shall be ineligible for inclusion in any such roll or claim to be included on grounds only of religion, race, caste or sex.







Disqualification for registration in an electoral roll under Section 16, RP Act 1950:

- Not a citizen of India.
- Of unsound mind declared by a competent court.
- Indulged in corrupt or fraudulent practices.
- Registration of a person more than once in a electoral roll.
- Enrollment of elector before expiry of period of disqualification

Qualification for Registration under Section 19 of RP Act, 1950:

Every person can be registered as an elector who:

- Is not less than 18 years of age on the qualifying date.
- Is ordinarily resident of the concerned Assembly constituency.
- Is a Citizen of India.

IMPORTANT DOCUMENTS FOR AGE PROOF-1

Required only for the applicant between 18 and 21 years.

In case where applicant is more than 21 years and physically appears to be so, no documentary proof should be insisted on.

Either of the documents can be given -

1. Birth certificate; or
2. School records; or
3. Passport; or
5. PAN card; or
6. Driving License; or
7. Aadhaar letter issued by UIDAI.

IMPORTANT DOCUMENTS FOR AGE PROOF-2

In case none of the above document is available;

1. declaration in prescribed format given in Annexure-1 to be made by either of the parents . In such case applicant will have to be present himself before BLO/AERO/ERO.
2. Further, if none of the above document is available and neither of the parents is alive, an age certificate given by *Sarpanch* of concerned *Gram Panchayat*/by a member of concerned municipal corporation/committee may be accepted.

- Used for deletion of name of a shifted / dead / absentee elector from the electoral roll. And also for deletion of a multiple entries in electoral rolls.
- During the time of hearing the applicant ‘Objector’ must prove as to why a particular name should to be deleted.
