No.Per (AP.B)B(1)-1/98 dated Shimla-171 002, the 6-10-1998

In exercise of the powers conferred by Article 162 read with proviso to the article 309 of the Constitution of India, the Governor of Himachal Pradesh is pleased to make the rules regulating appointment and terms and conditions of Chairman and Members of HP Subordinate Services Selection Board : namely :-

1. Short title and commencement :- (1) These rules may be called the HP Subordinate Services Selection Board Terms & Conditions (Chairman and Members), 1998.  
(2) These rules shall come into force from the date of publication in Rajpatra, H.P.

2. Definitions - In these rules unless the context otherwise requires :-

- (a) "The Board" means the Himachal Pradesh Subordinate Services Selection Board,
- (b) "Chairman" means Chairman of the Board,
- (c) "Member" means Member of the Board, and
- (d) "The total monthly emoluments" means "emoluments" as defined by the Government from time to time.

3. Appointment & Term of office of Chairman & Member - (1) The Chairman & Member of the Board shall be appointed by the State Govt. for a period of 05 (five) years from the date he enters upon his office or until he attains the age of 62 years in case of Member and 65 years in case of Chairman, whichever is earlier.

(2) Atleast one Member shall be appointed from amongst the persons who have rendered atleast 10 years (ten) service under the State or Central Govt., as the case may be, and who has drawn the last pay in the pay scale atleast equal to or higher than the Commissioner-cum-Secretary under the State Government.

4. Resignation and Removal - (1) The Chairman or Member may by notice in writing under his hand addressed to the Governor, resign his office ,

Provided that the Chairman or Member, shall unless he is permitted by the Governor to relinquish his office sooner, continue to hold office untill the expiry of three months from the date of receipt of such notice or untill a person duly appointed as his successor enters upon his office or untill the expiry of his term of office whichever is the earliest.

(2) Chairman or Member can be removed from his office by the Governor on the ground of proved misconduct after conducting of due inquiry in which he is given reasonable opportunity of being heard.

5. Oaths - (1) The Chairman and Member shall, on appointment, be required to take the oaths of allegiance, office and secrecy in the forms appended to these rules.

(2) The oath will be administered to the Chairman of the Board by the Chief Secretary to the Govt. of H.P. and to the Members by the Chairman of the Board.

6. Pay and Allowances - The Chairman and Members appointed to Board shall receive pay and allowances as admissible to the Financial Commissioner and Commissioners respectively under the State Government from time to time subject to the conditions specified in rule 10.

7.If the Chairman or a Member, at the time of appointment as such is a person retired from Government, a Local Body, a University or any other body wholly or substantially owned or controlled by the Government, he will be entitled to ,get such total monthly emoluments as last drawn, reduced by amount of pension, if any, (excluding pension equivalent to DCRG). He will however, draw full amount of pension, if any, in addition.

8.If the Chairman or a Member of the Board, at the time of appointment as such is a person serving under any Govt. he shall henceforth cease to be in the service of the Government and shall be entitled to draw pay subject to provision of sub rule 2 and 3 of rule 9 below.

9. (1) Such a person who at the time of appointment as Chairman, or a Member, is a person serving under any Government, shall be permitted to elect to draw his pension and other retirement benefits admissible to him under the relevant rules governing his service under the Government.

OR

Elect to count his service on the Board as qualifying service for the purpose of pension under the rules *ibid*. A time limit of six months from the date of his entry in office of the Board or from the date of publication of rules whichever is later may be allowed to exercise this option and the option so exercised shall be final.

(2) If such a person elects to draw pension for the service rendered by him under the Government prior to his appointment on the Board, his pay as Chairman or Member shall be fixed in the manner as prescribed in rule 7 *ibid*.

(3) If such a person elects to count his service on the Board as qualifying service, the retirement benefits admissible to him



will be subject to the overall ceiling of the amount of retirement benefits which such person would have drawn had he not been appointed to the Board and continued in service under the Government. He shall, however, not be permitted to retire on the day of superannuation which otherwise he would have attained had he not been appointed in the Board, he will be entitled to get his retirement benefits only when he finally quits the Board as a Chairman or a Member.

10. If the Chairman or a Member at the time of appointment as such, is serving under a Local Body, a University or any other Body wholly or substantially owned or controlled by the Government, he shall be entitled to draw total monthly emoluments as last drawn, reduced by the amount of pension (excluding pension equivalent to DCRG) if he is in receipt of pension from local body, a University or any other body.

Notwithstanding any thing contained in these rules, the Chairman and Members shall be entitled to receive the pay scales of Financial Commissioner and Commissioner respectively subject to the condition that the pay plus gross pension shall not exceed Rs.26,000/- per month.

11. Leave - Chairman and Members will be entitled for leave as admissible under CCS (Leave) Rules, 1972.

12. Pension - In the case of a retired Government Servant, service as Chairman or Member shall not count as qualifying service for the purpose of re-calculating his pension (and other retirement benefits) at the expiry of his tenure of office as Chairman / Member.

13. Provident Fund.- The Chairman or a Member shall be eligible to elect to subscribe to the General Provident Fund in accordance with the General Provident Fund Rules in force from

time to time in Himachal Pradesh. If the Chairman or the Members so elect, they shall be entitled to carry forward the balance in their respective Provident Fund Account to the New Provident Fund Account.

14.- Travelling Allowance.- (1) The Chairman or a Member of the Board :-

(a) in case he is a serving Govt. officer, be entitled to such travelling allowance as is admissible to him under the TA rules applicable to the officers of the State Government, and

(b) in case, he is not a Govt officer, be entitled to such travelling allowance as is admissible to an officer of Grade-I of the State Govt.

(2) The Chairman or a Member, who on the date of his appointment was in the service of any Government in India, shall be entitled to travelling allowance as on transfer (1).

15. House Rent Allowance - The Government may either provide Residential Accommodation or in lieu thereof the Chairman or a Member will be entitled for HRA according to their pay scales as admissible under State Government.

16. Medical Attendance.- For the purpose of medical attendance, Chairman or a Member shall be governed by the Central Service (Medical Attendance) Rules, 1944, or any other rules applicable from time to time to employees of the Himachal Pradesh Government, as the case may be.

17. Conditions of service in residuary matters.- In respect of any matter for which there is no provision in these rules the Chairman and other Members of the Board shall be governed by such Rules and Orders for the time being applicable to equivalent class of Government officers.

18. Power to remove difficulties.- If any difficulty arises in giving effect to the provision of these rules, the State Government may make such provisions or give such directions as may appear to it necessary or expedient for removal of such difficulty.




