OFFICE MEMORANDUM

Subject:-

Eligibility of Foreign Nationals for
Appointment to the posts in the State
Government-Amendment of R & P Rules.

The undersigned is directed to say that the matter of issuing Eligibility Certificate to Foreign Nationals to make them eligible for appointment in the Govt. services was under consideration of the State Government for quite some time past. After careful consideration, the Government has now decided to retain only Indian Citizens as eligible for the appointment in State Services.

2. Pursuant to this decision of the Government, Rule-14 of the existing Standard Proforma for Framing of R & P Rules (Essential requirement for a direct recruitment) shall have to be amended in the manner as under:-

" Rule-14:- A candidate for appointment to any service or post must be a Citizen of India."

3. All the Codal formalities have been completed by the Department of Personnel in the matter and as such, all the Departments are requested to amend the provision of Rule 14 of the existing R & P Rules of such categories where there is a provision for direct recruitment accordingly at their own level.

4. It is clarified that these instructions are applicable only for appointment to the posts or Services under the State and not for engagement of casual workers/labourers on muster rolls, contract appointments etc. which are project/work specific.
