In continuation of this Department's Notification of even number dated 30<sup>th</sup> May, 2012, the Governor of Himachal Pradesh is pleased to make the following terms and condition of the Vice-Chairman of the H.P. Employees/Other Workers/Pensioners Welfare Board: -

- 1. He will be entitled to Rs. 200/- per day during the tour.
- 2. He will be entitled to semi furnished accommodation of the Board if available, on payment of the rent as per norms fixed by the Government. In the eventuality of non-availability of accommodation with the Board, he will be entitled to Rs. 4000/- per month as House Rent. In case his services are not required by the said Board, he shall vacate the accommodation within 15 days from the date of withdrawal of his nomination on the post. On receipt of House Rent in lieu of accommodation, he shall not be entitled to any furniture charges.
- 3. The concerned Board will provide vehicle to the Vice-Chairman and the expenditure will be borne by the Government.
- 4. The expenditure incurred for the payment of Electricity and Water Bill will be borne by the government.
- 5. Vice-Chairman will be entitled to Rs. 1500/- per month as Sumptuary Allowance.
- 6. In the office of VC, the concerned Board will provide the facility of Telephone. To meet the expenses of Telephone/Mobile Phone, he will be entitled to Rs. 3800/- (Fixed) bi-monthly.
- 7. He will be entitled to the free medical facility as admissible to the MD and CEO of the Board/Corporation.



- 8. He will be competent to countersign his Daily Allowance Bills and will be the Controlling Officer for approving his own tour programmes.
- 9. He will be entitled to remuneration of Rs. 10,000/- per month.
- 10. He will be entitled to Road Mileage Allowance @ Rs. 6.00 per KM if he travels by his private vehicle on official tour of the Board.
- 11. His tenure will be of 3 (three) years.
