General Transfers of Government employees - Lifting of Ban.


Sir,

I am directed to say that it has been decided by the Government to lift ban on transfers w.e.f. 16-04-2010 to 31-05-2010. Transfers may be ordered during this period and while doing so, the following instructions/decisions shall be strictly complied with: -

1. Schedule for transfer will be as under :-
  - (i) 16<sup>th</sup> April to 5<sup>th</sup> May 2010- receipt of application & proposals.
  - (ii) 6<sup>th</sup> May to 20<sup>th</sup> May, 2010- processing of proposals/transfer requests by the Department concerned.
  - (iii) 21<sup>st</sup> May, to 31<sup>st</sup> May, 2010- issuing of orders.
2. Ministers Incharge are authorised to approve/decide transfer in their respective Departments in respect of all categories of employees.
3. Departments will ensure that the transfers will be limited to maximum 6 % of the total cadre strength of the Department.
4. With effect from 1<sup>st</sup> June, 2010 the ban on transfers will again become operative.

These instructions may be brought to the notice of all concerned for strict compliance.
