**ORDER**

In the matter of: CWP No. 6260/2026- Smt. Diksha Thakur, TGT(NM) Vs. State of H.P. and others.

Whereas, Smt. Diksha Thakur, TGT(NM) presently working in GSSS Sahal, Distt. Mandi has filed CWP No.6260/2026 titled as Smt. Diksha Thakur Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that she may be transferred from GSSS Sahal, Distt. Mandi to one of the stations of her choice in Distt. Mandi. The case of the petitioner was listed before the Hon'ble High Court on 28.04.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

*"As prayed for, this petition is disposed of with the direction that let representation (Annexure P-3) of the petitioner be decided by the Competent Authority, in the light of the averments contained therein, by passing a speaking order, within a period of 8 weeks' from today, in accordance with law. Pending miscellaneous application(s), if any, also stand disposed of accordingly."*

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 05.06.2025 and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GSSS Sahal, Distt. Mandi to GHS Babli or GMS Kasoun u/c GSSS Dhar or GMS Tharki u/c GSSS Kufri or GSSS Dhar, Distt. Mandi, against longer stayee on mutual basis .

After perusal of relevant record, it is revealed that the petitioner has been working in GSSS Sahal, Distt. Mandi since 01.10.2022. One Smt. Dinesh Kumari, TGT(NM) has been working in GMS Kasoun u/c GSSS Dhar, Distt. Mandi since 05.01.2022 and both have completed their normal tenure at their present places of posting.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is hereby transferred from GSSS Sahal, Distt. Mandi to GMS Kasoun u/c GSSS Dhar, Distt. Mandi vice Smt. Dinesh Kumari, TGT(NM) and vice versa on mutual basis, without TTA/JT.

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
