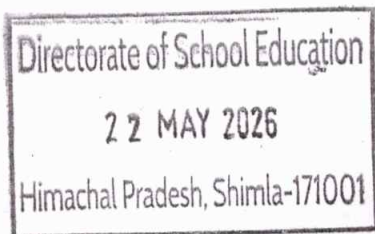

ORDER

Whereas, the petitioner namely Smt.Anita Rathore Lect.(Hindi) is working at GSSS Jugar (Sml) w.e.f 21.06.2016 and completed her normal stay. She has filed CWP No. 4994/2026 titled as Anita Rathore vs State of HP. This petition was listed on 09.04.2026 when the same was finally disposed with the directions to respondents as under:-

“As prayed for, this petition is disposed of with the direction that let representation (Annexure P-1) of the petitioner be decided by the Competent Authority, in the light of the averments contained therein, by passing a speaking order and by affording an opportunity of personal hearing to the petitioner, within a period of 8 weeks’ from today, in accordance with law. In the course of deciding the representation, if the Authority finds favour with the prayer made by the petitioner, then it goes without saying that transfer shall be effected only after the ban on the transfers on account of the Panchayati Raj Election is lifted by the State. Pending miscellaneous application(s), if any, also stand disposed of accordingly”

And whereas, in compliance of Hon’ble High Court order dated 09.04.2026, the petitioner was called for personal hearing on 19.05.2026 and was present on this date. During the course of hearing petitioner has pleaded that, she is completed ten years at one station and unable to continue her services due to her medical problems and unavoidable family circumstances. The petitioner, therefore, requested that she may kindly be transfer to GSSS Neen (Sml) against vacancy due to retirement of present incumbent on 31May 2026.

And whereas, upon passing of the above direction, the representation of petitioner has been persued and examined that the post of Lect(Hindi) is going to vacant at GSSS Neen (Sml) on 31.05.2026 due to retirement of present incumbent and stay of petitioner is complete.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a representation of petitioner has been considered and allowed. The petitioner i.e Smt.Anita Rathore Lect.(History) is being transferred from GSSS Jugar (Sml) to GSSS Neen (Sml) against vacancy due to retirement of present incumbent on 31.05.2026 as per her request on medical ground with the condition that these orders shall come into force on or after 01.06.2026. Hence representation stands disposed of.
