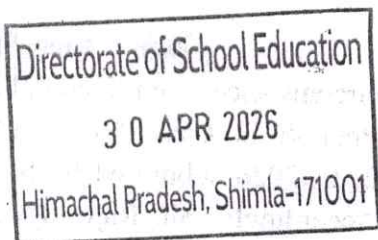

ORDER

Whereas, Sh. Rajiv Thakur, Lecturer (English), presently posted at GSSS Haripurdhar, District Sirmaur, and Smt. Karuna Kumari, Lecturer (English), presently posted at GSSS Charna, District Sirmaur, are spouses;

And whereas, vide office orders dated 07.04.2026, Sh. Rajiv Thakur was transferred from GSSS Haripurdhar, District Sirmaur, to GSSS Railla, District Chamba, against vacancy, and Smt. Karuna Kumari was transferred from GSSS Charna, District Sirmaur, to GSSS Sangna Satahan, District Sirmaur;

And whereas, aggrieved by their respective transfer orders, Sh. Rajiv Thakur filed CWP No. 5181/2026 titled Rajiv Thakur vs. State of H.P. & others and Smt. Karuna Kumari filed CWP No. 5183/2026 titled Karuna Kumari vs. State of H.P. & others before the Hon'ble High Court of Himachal Pradesh;

And whereas, both the aforesaid writ petitions were disposed of by the Hon'ble High Court vide judgments dated 16.04.2026 with identical directions, permitting the petitioners to submit representations within one week for adjustment at stations of their choice. The Hon'ble Court further directed that an endeavour be made to post the petitioners either at stations of their choice or at nearby stations. It was also clarified that the stations of choice to be submitted by the petitioners shall not be in District Sirmaur nor in the immediate contiguous districts, while keeping in view the factum of their couple case;

And whereas, in compliance with the directions of the Hon'ble High Court, both were afforded an opportunity of personal hearing on 27.04.2026. During the course of personal hearing, Sh. Rajiv Thakur, vide representation dated 27.04.2026, requested his adjustment/transfer to GSSS Nakrana, District Bilaspur, against an available vacant post of Lecturer (English) and Smt. Karuna Kumari, vide representation dated 27.04.2026, requested her adjustment/transfer to GSSS Swahan, District Bilaspur, against an available vacant post of Lecturer (English) on couple grounds;

And whereas, the matter has been examined in detail in the light of the judgments of the Hon'ble High Court, the applicable transfer policy, availability of vacancies, administrative exigencies, and the policy governing couple cases;

And whereas, both the requested stations are situated in District Bilaspur, which is neither District Sirmaur nor an immediate contiguous district thereof, thereby satisfying the condition imposed by the Hon'ble High Court;

And whereas, accommodating both petitioners in District Bilaspur would serve the ends of justice, appropriately address their couple case, and be in consonance with the spirit of the Government transfer policy as well as the directions of the Hon'ble High Court;

Now, therefore, after careful consideration of all relevant facts and circumstances, and in compliance with the directions of the Hon'ble High Court of Himachal Pradesh in CWP No. 5181/2026 and CWP No. 5183/2026, the representations dated 27.04.2026 submitted by Sh. Rajiv Thakur and Smt. Karuna Kumari are hereby accepted. Accordingly, Sh. Rajiv Thakur, Lecturer (School-New) (English), who is under orders of transfer from GSSS Haripurdhar (Sirmaur) to GSSS Railla (Chamba) is hereby adjusted at GSSS Nakrana (Bilaspur) against vacancy as per his request without TTA/JT and Smt. Karuna Kumari, Lecturer (School-New) (English) who is under orders of transfer from GSSS Charna (Sirmaur) to GSSS Sangna Satahan (Sirmaur) is hereby adjusted at GSSS Swahan (Bilaspur) against vacancy without TTA/JT as per her request.


In view of the above observations, both representations stand disposed of accordingly.
