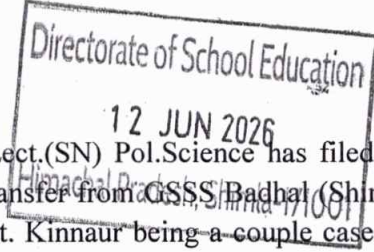

**ORDER**



Whereas, Sh. Ram Chander Lect./Lect.(SN) Pol.Science has filed CWP No. 4941/2026 before the Hon'ble High Court regarding seeking his transfer from GSSS Badhal (Shimla) to one of the station of her choice i.e. GSSS Tangling/GSSS Barang Distt. Kinnaur being a couple case in term of clause 5.4 of transfer policy as the petitioner wife is working as JBT at GPS Kalpa (KNR).

The case was listed before the Hon'ble Court on 09.04.2026 when the case was disposed of with the following directions:-

**“prayed for, this petition is disposed of with the direction that let representation (Annexure P-1) of the petitioner be decided by the Competent Authority, in the light of the averments contained therein, by passing a speaking order and by affording an opportunity of personal hearing to the petitioner, within a period of 8 weeks' from today, in accordance with law. In the course of deciding the representation, if the Authority finds favour with the prayer made by the petitioner, then it goes without saying that transfer shall be effected only after the ban on the transfers on account of the Panchayati Raj Election is lifted by the State. Pending miscellaneous application(s), if any, also stand disposed of accordingly.”**

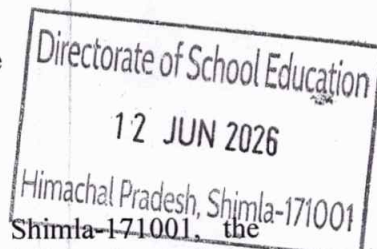
**And whereas,** in compliance of Hon'ble High Court direction petitioner was called for personal hearing on 05.06.2026. During the course of hearing petitioner has informed that he has completed his normal tenure at present place of posting as well as his wife is serving as JBT at GPS Kalpa II (KNR), further requested being a couple case he may kindly be adjusted at GSSS Tangling or GSSS Brang Distt. Kinnaur against vacancy.

**And whereas,** while examining his representation it is found that at present Sh. Ram Chander Lect./Lect. (SN)Lect. Pol. Science is working at GSSS Badhal (SML) w.e.f. 05.05.2023 & has completed his normal tenure, but he is posted in soft area, and as per “Comprehensive Guiding Principles-2013” for the regulation the transfer of State Government employees it is clearly mentioned at Rule No.-12.1 that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of State Government of post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience.

Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected, With these observations, representation stands disposed of.
