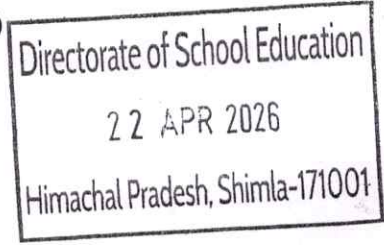

ORDER

Whereas, Smt. Santosh Kumari, Lecturer (School-New) (Sociology), presently posted at GSSS Dadoh, Distt. Mandi, filed CWP No. 3037/2026 before the Hon'ble High Court for seeking direction to the respondent to decide her pending representation wherein she has requested her transfer from GSSS Dadoh (Mandi) to GSSS Dehar, Distt. Mandi, against vacancy on compassionate grounds as her mother is presently bedridden.

The case was listed before the Hon'ble Court on 16.3.2026 when the case was disposed of with the following directions:-

“Without making any observation on the merit of the case, this writ petition is accordingly disposed of with the direction that the representation made by the petitioner, appended with the writ petition as Annexure P-1, shall be decided by the competent Authority, in light of the averments made therein within a period of 8 weeks from today, by passing a speaking order, in accordance with law. Pending miscellaneous application(s), if any, also stand disposed of accordingly”.

And whereas, in compliance with the directions of the Hon'ble High Court, the petitioner was afforded an opportunity of personal hearing on 20.04.2026. During the course of the hearing, the petitioner submitted that her mother is suffering from a serious illness and is presently bedridden, requiring constant medical care and personal attention. She further submitted that she is the sole child of her parents and that no other family member is available to take care of her mother. It was also submitted that, owing to her present posting being at a distant place from her hometown, she is facing considerable difficulty in discharging her official duties while simultaneously attending to her family obligations.

And whereas, the representation of the petitioner has been examined in detail, and it is observed that the post of Lecturer (Sociology) is presently not vacant at GSSS Dehar (Mandi). However, during the course of the personal hearing, the petitioner submitted a fresh representation indicating her preferred station as GSSS Jai Devi (Mandi), where a vacancy for the post of Lecturer (Sociology) is currently available.

Now, therefore, in view of the facts stated above, the representation of the petitioner is hereby considered sympathetically. Accordingly, Smt. Santosh Kumari, Lecturer (School-New) (Sociology), is hereby transferred from GSSS Dadoh, District Mandi, to GSSS Jai Devi, District Mandi, against a vacant post, without TTA/JT, on her own request. The representation stands disposed of.
