**ORDER**

In the matter of: CWP No. 3443/2026- titled as Mamta Devi, TGT (NM) Vs. State of H.P. & others.

Whereas, Smt. Mamta Devi, TGT (NM) presently working in GSSS Kiri, District Chamba has filed CWP No. 3443/2026 titled as Mamta Devi, TGT (NM) Vs. State of H.P. & others. before the Hon'ble High Court, seeking the relief that she may be transferred from GSSS Kiri, District Chamba to one of the stations of her choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 20.03.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

*"Without making any observation on the merit of the case, this writ petition is accordingly disposed of with the direction that the representation made by the petitioner, appended with the writ petition as Annexure P-3, shall be decided by the competent Authority sympathetically, in light of the averments made therein within a period of 6 weeks from today, by passing a speaking order, in accordance with law. Pending miscellaneous application(s), if any, also stand disposed of accordingly."*

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 06.04.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GSSS Kiri, Distt. Chamba to GSSS Garh Jamula or GSSS Dhatti or GMS Kadar Mandir u/c GSSS Daroh or GHS Bari or GSSS Purba or GSSS Moondi, Distt. Kangra against longer stayee.

After perusal of the relevant record, it is revealed that the petitioner has been working in GSSS Kiri, District Chamba since 25.07.2023. GSSS Kiri which falls under hard area. The said teacher has completed his normal tenure in hard area i.e. two winters and three summers. One, Sh. Shamsheer Singh, TGT (NM) has been working in GSSS Dhatti, Distt. Kangra since 19.08.2021 and has completed his normal tenure at his present place of posting.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and she is hereby transferred from GSSS Kiri, District Chamba to GSSS Dhatti, Distt. Kangra without TTA/JT vice Sh. Shamsheer Singh, TGT (NM) and vice versa with TTA/JT.

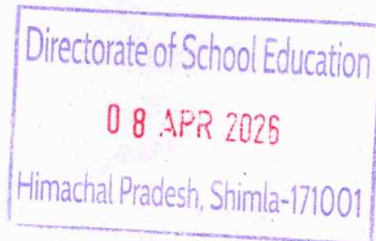
Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
