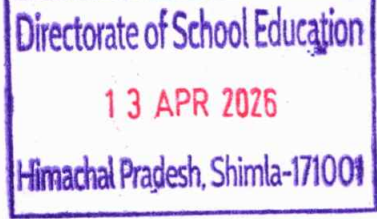

ORDER



In the matter of:- CWP No. 2613/2026-titled as Kanta Devi, TGT (Arts) V/s. State of HP.

The petitioner has filed present CWP No. 2613 of 2026 in the Hon'ble High Court vide which sought her transfer from GHS Mathiana u/c GSSS Thaltukhod (MND) to his choice of school. The present CWP was listed before the Hon'ble High Court of H.P. on dated 06.03.2026, on this day Hon'ble Court has passed order/judgment. The operative portion of the order/judgment is as under:-

“.....the representation filed by the petitioner be decided by the Competent Authority in light of the averments made therein”

In compliance with the orders/judgment passed by the Hon'ble High Court of Himachal Pradesh, the petitioner was called for a personal hearing on 06.4.2026 and appeared before the undersigned. During the hearing, the petitioner, Smt. Kanta Devi, TGT (Arts), submitted fresh representation and stated that she is working at GHS Mathiana u/c GSSS Thaltukhod Distt. Mandi and requested for transfer/adjustment at GSSS Siun, GMS Gawali u/c GSSS Padhar, GMS Ghatasni u/c GSSS Gumma, GSSS Urla Distt. Mandi on account of completion of his normal tenure of posting at present place of posting.

From the perusal of the record, it is found that Smt. Kanta Devi, TGT (Arts), has been working at from GHS Mathiana u/c GSSS Thaltukhod Distt. Mandi since 11.10.2022 wherein about 44 students are enrolled and petitioner has completed his normal tenure at present place of posting i.e. sub cadre area. Further, at present no any post of TGT (Arts) is lying vacant in the choice schools of petitioner but one incumbant Sh./Smt Sudershan, TGT (Arts) is posted at GSSS Siun Distt. Mandi w.e.f. 09.9.2022 and completed her normal tenure at present place of posting.

In view of the above circumstances, the representation of the petitioner has been considered sympathetically and the petitioner, Smt. Kanta Devi, TGT (Arts) posted at GHS Mathiana u/c GSSS Thaltukhod Distt. Mandi is hereby transferred to GSSS Siun Distt. Mandi vice Sh./Smt. Sh./Smt Sudershan, TGT (Arts) and vice versa basis (with TTA/JT in r/o Sh./Smt Sudershan, TGT (Arts)). Therefore, representation of the petitioner with the present CWP is disposed of. All the concerned are intimated accordingly.

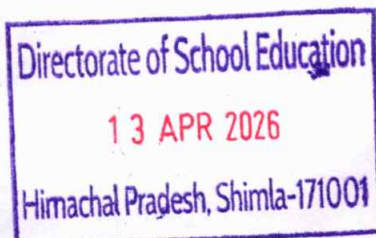
