ORDER.

In the matter : CWP No. 17533/2025 titled as Neena Rani, TGT(Med) VS State of H.P. & others.

The Petitioner Smt. Neena Rani, TGT(Med) filed CWP No. 17533/2025 titled as, Smt. Neena Rani, TGT(Med) Vs State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS, Nihalgarh Distt. (Smr.) to District Una. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 12.11.2025, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

*"True it is that petitioner has not competed normal tenure of posting at the present place of posting, but once Transfer Policy, formulated by the Government of Himachal Pradesh, enables an employees to seek transfer on medical grounds, this Court, without going into the merits of the case, deems it fit to dispose and decide her pending representation (Annexure P-1) expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority of being opportunity of being heard to the petitioner and pass appropriate orders."*

As per the directions of the Hon'ble High Court, the petitioner was called for a personal hearing on 28.03.2026. The petitioner attended the hearing on the scheduled date and time and submitted a representation seeking her adjustment in District Una or Kangra, as mentioned in Annexure P-1.

From the perusal of the record, it reveals that Smt. Neena Rani, TGT (Med.) is working in GSSS, Nihalgarh District Sirmour since 04.10.2023 and having short stay at present place of posting. Moreover, the said station falls under a soft area.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
