All other terms and conditions of the aforesaid Office Order shall remain unchanged and shall continue to be in force.

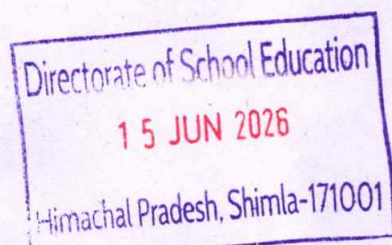
