OFFICE ORDER

In the matter of: CWP No. 18290/2026-titled as Hem Raj, (Lect. Physics) Vs. State of H.P & Others.

Whereas, Sh. Hem Raj, Lect. Physics preferred CWP No. 18290/2026 titled as Hem Raj, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Showad, Distt. Kullu, H.P to nearby home town in Distt. Hamirpur. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 22-04-2026 when the Hon'ble High Court has passed the following orders:-

3. " This petition is accordingly disposed of with the direction that let the petitioner file a fresh representation within a period of two weeks from today and appropriate orders thereupon shall be passed by the competent Authority within a period of four weeks as from the date of receipt of the representation, in accordance with law, by adhering to the principles of natural justice. Pending miscellaneous application(s), if any, also stand disposed of accordingly. List for compliance on 25.05.2026."

In compliance to the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 19-05-2026. He attended the same and submitted his representation in this office, vide which he has requested that he may be transferred from GSSS Showad, Anni, Distt. Kullu, H.P to GSSS Kakkar, Distt. Hamirpur, H.P, against vacancy.

From perusal of record, it has been found that the petitioner has been working at GSSS Showad, Anni, Distt. Kullu, H.P. w.e.f. 04-05-2021 and has completed is normal stay. The aforesaid school falls in soft area and petitioner is not entitled for transfer to the station of his choice. At present 04 students are studying in Physics subject at GSSS Showad, Anni, Distt. Kullu. If the petitioner is to be transferred from GSSS Showad (Kullu) to his choice of station the study of students may be hampered. However, as per "Comprehensive Guiding Principles- 2013" for the regulation the transfer of State Government employees it is clearly mentioned at Rule No.-12.1 that no Government employee can claim his transfer or posting as a matter of right. It will be the discretion of State Government of post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience. Now therefore, after taking into account the above discussed detail fact and circumstances, the request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been rejected and stands disposed of.
