In partial modification of this department's Notification of even number dated 18.02.2026, the Governor, Himachal Pradesh is pleased to order the cancellation of merger of the following schools:-

1. Merger of PM Shri Bakshi Tek Chand Government Model Girls Senior Secondary School, Nurpur and Government Senior Secondary School Boys, Nurpur Distt. Kangra into a single Co-Educational School namely; Bakshi Tek Chand PM SHRI Government Model Senior Secondary School, Nurpur .
2. Merger of PM Shri Government Girls Senior Secondary School, Dharamshala and Government Senior Secondary (Boys) School, Dharamshala Distt. Kangra into a single Co-Educational School namely; PM SHRI Government Senior Secondary School, Dharamshala.
3. Merger of PM Shri Government Model Senior Secondary School, Sarkaghat and Government Senior Secondary (Girls) School, Sarkaghat Distt. Mandi into a single Co-Educational School namely; PM SHRI Government Model Senior Secondary School, Sarkaghat.
4. Merger of PM Shri Government Model Senior Secondary School, Dehra and Government (Girls) Senior Secondary School Dehra, Distt. Kangra into a single Co-Educational School namely; PM SHRI Government Model Senior Secondary School, Dehra.

The Governor, Himachal Pradesh is further pleased to order that, in all the above cases, one school shall be affiliated with CBSE and the other with the Himachal Pradesh Board of School Education. Both schools shall be co-educational in nature. The school affiliated with the Himachal Pradesh Board of School Education shall function as a High School, while the school affiliated with CBSE shall function as a Government Senior Secondary School.

The Director of School Education shall determine which premises will be allocated to the CBSE-affiliated school and which will be designated for the school affiliated with the Himachal Pradesh Board of School Education, after examining the necessary components such as infrastructure and other relevant factors.
