ORDER

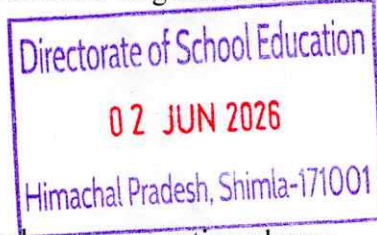
In the matter of: CWP No. 4576/2026 titled as Manu Kumari, TGT (NM) Vs. State of H.P. & others.

Whereas, Smt. Manu Kumari, TGT (NM) presently working in GMS Tikkri u/c GSSS Gumma, Distt. Shimla has filed CWP No. 4576/2026 titled as Manu Kumari, TGT (NM) Vs. State of H.P & others. before the Hon'ble High Court, seeking the relief that She may transferred from GMS Tikkri u/c GSSS Gumma, Distt. Shimla to one of the stations of her choice in Distt. Hamirpur. The case of the petitioner was listed before the Hon'ble High Court on 06.04.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

"As prayed for, this petition is disposed of with the direction that representation (Annexure P-1) filed by the petitioner be decided by the Competent Authority within a period of twelve weeks from today in terms of the contents therein. Pending miscellaneous application(s), if any, also stand disposed of"

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 19.05.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner requested that she may be transferred from GMS Tikkri u/c GSSS Gumma to GMS Lalyar u/c GSSS Samirpur or GSSS Darbiar or GMS Jhanikar u/c GHS Barara or GSSS Tauni Devi or GSSS Kot, Distt. Hamirpur.

After perusal of the relevant record, it is revealed that the petitioner has been working at GMS Tikkri u/c GSSS Gumma, Distt. Shimla since 04.12.2019. Though the said teacher has completed her normal tenure of three years at GMS Tikkri u/c GSSS Gumma, Distt. Shimla but at present, vacancies are not available in the above mentioned schools where petitioner requested for transfer. The cadre of the TGT (NM) is State Cadre and can be transferred/posted in the state as per transfer policy. As per provision contained in Comprehensive Guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenience, hence the request of the petitioner cannot be acceded.
