स्कूल शिक्षा विभाग सूचित करता है कि विभाग कनिष्ठ बुनियादी अध्यापक के दिव्यांग अभ्यर्थियों के लिये आरक्षित पदों को प्रचलित भर्ती एवम् पदोन्नति नियमों के अनुरूप अधीनस्थ सेवाएं चयन बोर्ड हमीरपुर या बोर्ड ऑफ स्कूल एजुकेशन धर्मशाला से जे0बी0टी0 अध्यापक पात्रता परीक्षा में उत्तीर्ण हुए अभ्यर्थियों में से **जॉब ट्रेनी आधार पर**, सामाजिक न्याय एवम् अधिकारिता विभाग, हिमाचल प्रदेश के पत्र संख्या SJE-B-B(15)03/2014-I dated 28-08-2017 (प्रति संलग्न) में उल्लिखित मापदंडों के आधार पर भरने जा रहा है। इन पदों को जॉब ट्रेनी आधार पर **स्थिर वेतन रू0-18000/-** के अनुसार भरा जाएगा, प्रार्थी की आयु 18 से 45 वर्ष के मध्य होनी चाहिए, प्रार्थी को ऊपरी आयु सीमा में नियमानुसार छूट दी जाएगी। पदों का जिलावार विवरण निम्न प्रकार से है:-

**आवेदन प्रक्रिया :** पात्र अभ्यर्थी अपना पूर्ण विवरण निर्धारित बायोडाटा प्रपत्र में भरकर स्थायी पते, शैक्षणिक/व्यावसायिक योग्यता तथा अन्य आवश्यक प्रमाण-पत्रों की स्वप्रमाणित प्रतियों सहित निदेशक स्कूल शिक्षा, हिमाचल प्रदेश, लालपानी, शिमला-171001 के नाम दिनांक **22.08.2026** तक डाक/स्पीड पोस्ट के माध्यम से प्रेषित कर सकते हैं अथवा कार्यालय समय के दौरान व्यक्तिगत रूप से निदेशालय कार्यालय में जमा करवा सकते हैं। **बायोडाटा फार्म विभागीय वैबसाइट पर उपलब्ध है।**

**अनिवार्य शैक्षणिक एवं व्यावसायिक योग्यता :** आवेदक के पास कनिष्ठ बुनियादी अध्यापक (JBT) पद हेतु प्रचलित भर्ती एवं पदोन्नति नियमों दिनांक **19.02.2025 (R&P Rules)** तथा राष्ट्रीय अध्यापक शिक्षा परिषद (NCTE) द्वारा समय-समय पर निर्धारित न्यूनतम शैक्षणिक एवं व्यावसायिक अर्हताएं होनी चाहिए तथा अभ्यर्थी द्वारा हिमाचल प्रदेश स्कूल शिक्षा बोर्ड, धर्मशाला अथवा सरकार द्वारा अधिकृत किसी अन्य एजेंसी द्वारा आयोजित अध्यापक पात्रता परीक्षा उत्तीर्ण की गई हो। अधूरे/अस्पष्ट आवेदन कार्यालय द्वारा स्वीकार नहीं किए जाएंगे। साक्षात्कार की तिथि विभाग द्वारा पात्र आवेदकों को विभागीय website, बुलावा पत्र तथा समाचार पत्रों के माध्यम से सूचित की जाएगी।

**Note:- (A) The candidate shall be eligible for appointment, if he/she has passed Matriculation and 10+2 from any school/Institution situated within Himachal Pradesh. Provided this condition is not applied to Bonafide Himachalis. Candidate who has not passed Teacher Eligibility Test from HPSSSB Hamirpur or Board of School Education Dharamshala are also not eligible for the post.**

6. Parental Caste Certificate (In case of SC/ST/OBC).
7. Permanent Physically Handicapped Category Certificate/Card.
8. Character Certificate issued by the concerned SDO(C)/Tehsildar/Naib Tehsildar.
9. Notified Backward Area or Panchayat. (If applicable.)

**Note:-**

1. The certificate of Backward Area /Panchayat, Landless family/family having less than 1 hectare land, non-employment/income certificate etc. shall be issued by the concerned SDO(C)/Tehsildar/Naib Tehsildar.
2. The BPL certificate, Widow/Divorced/Destitute/Single Woman /Single Daughter /Orphan etc. shall be certified/issued by the concerned B.D.O./Competent Authority by taking the authenticated entries in the 'Parivar Register' as the basis of such certificate.
3. Differently abled person certificate shall be issued by the H&FW Authorities/Medical Boards.
4. All the candidates must bring the above said certificates at the time of counseling duly issued by the competent authority as per the directions issued by the Government from time to time. No document w.r.t. above parameter should be entertained once the candidate is counseled.

5. The candidates shall be allotted District as per his/her rank in the overall merit list read with the order of preference of the candidates.
6. The appointment of JBTs shall be made strictly on Job Trainee basis in accordance with the Government of Himachal Pradesh Department of Personnel Notification No. PER(AP)-C-B(15)-3/2024 dated 19.07.2025, as amended from time to time, and as per the existing R&P Rules dated 19.02.2025 (available on the official website of this Directorate at himachal.nic.in/dse), read with the NCTE norms and guidelines issued from time to time and Government instructions issued vide letter No. EDN-C-A(3)-1/2016-Vol-I dated 27.09.2023.
