**ORDER**

In the matter of: CWP No. 3091/2026- Sh. Sushil Kumar, TGT(NM) Vs. State of H.P. and others.

Whereas, Smt. Sushil Kumar, TGT(NM) presently working in GMS Khehar u/c GSSS Raja Ka Talab, Distt. Kangra has filed CWP No.3091/2026 titled as Sh. Sushil Kumar Vs. State of Himachal Pradesh before the Hon'ble High Court, seeking the relief that he may be adjusted at one of the stations of his choice in Distt. Kangra. The case of the petitioner was listed before the Hon'ble High Court on 17.03.2026 when after hearing the matter the Hon'ble court was pleased to dispose of the above mentioned CWP with the following directions/Order :-

*“ In light of the fact that the petitioner is serving in and around the station from where he presently stands transferred, though this Court is not interfering with the transfer order, but this petition is disposed of with the direction that the representation, which the petitioner has filed, i.e. Annexure P-5, be decided by the Competent Authority within a period of two weeks from today, taking into consideration the medical issue pointed out by the petitioner and till then, he shall not be forced to join at the station to which he stands transferred and he can avail the kind of leave due to him. Pending miscellaneous application(s), if any also stand disposed of accordingly. ”*

In compliance to the directions of the Hon'ble High Court, the petitioner was called for personal hearing on 20.04.2026 by the undersigned and the petitioner attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the petitioner stating that he is suffering from Diabetes Mellitus and Epilepsy since the year 2017 and also requested that he may be adjusted at GMS Niyal u/c GSSS Bharmar or GSSS Bharmar or GSSS Siddhpur or GSSS Harsar or GSSS Maira, Distt.Kangra against longer stayee on medical grounds.

After perusal of the relevant record, it is revealed that the petitioner was transferred from GMS Khehar u/c GSSS Raja ka Talab, Distt. Kangra to GSSS Dhullara, Distt. Chamba vide Secretary(Education) to the Government of Himachal Pradesh vide order dated 02.03.2026 in view of CWP No. 2149 of 2026. One, Smt. Sunita Kumari, TGT(NM) has been working in GSSS Bharmar, Distt. Kangra since 23.08.2022 and has completed her normal tenure of three years at her present place of posting.

Therefore, keeping in view the position stated above, the representation made by the petitioner is considered sympathetically and he is hereby adjusted without TTA/JT in GSSS Bharmar, Distt. Kangra vice Smt. Sunita Kumari, TGT(NM), who may be transferred to GSSS Dhullara, Distt. Chamba, with TTA/JT in place of Sh. Sushil Kumar, TGT(NM).

Therefore, the representation of the petitioner is disposed of after due consideration. All the concerned be intimated accordingly.
